Other Uses of (a)(1) Institutional Portion funds. <sup>4</sup>	\$241,441.76			During the June 2020 Technical Assistance webinar, the allowability of lost revenue was raised. The USDOE replied the institutional share can be used for lost revenue as long as “you can account for the funds and you can attribute the expenditures directly to the disruption which includes losing revenue.” Based on this guidance, SGTC calculated \$241,441.76 for lost revenue related to dormitory and cafeteria operations. This amount was determined by calculating an average of Spring and Summer Semesters for the prior 2 fiscal years and subtracting FY20’s actual revenue from that average. SGTC has currently closed the FY20 financial records and prepared all of the financial reports. Going forward in FY21, based on the October 2020 HEERF Round 3 FAQs addressing lost revenue, we will no longer use Recipient’s Institutional Relief (a)(1) funds for lost revenue.
